About the Educational Society:

The School is being run by Private Registered Society called "**Makhish Educational Society**", **18-04-233/1, Jangareddygudem** which was Registered under Certificate of Registration of Societies Act. 2001 with Registration No.23/2022, Dt.04.03.2022. A copy of Certificate of Registration along with full bye-laws Copy is herewith enclosed to the Proposals.

Furniture:

The School Management has provided sufficient furniture for the Classes and the List of the Furniture is enclosed to the proposals.

Play Ground:
